# Marple's newsletter sold to Oregon publisher

One of the region's most venerable business publications, Marple's Northwest Business Letter, will soon move its head-quarters from Seattle to Eugene, Ore.

Michael Parks, who has owned the twice-monthly newsletter since 1980, has sold it for an undisclosed price to Eugene-based Random Lengths Publications Inc., a publisher of forest products trade data.

"I've done this for long enough," Parks said from his 600-square-foot office near the Space Needle. "I'm 65. Mrs. Parks and I have both worked all our lives."

The new editor, Eugene Register-Guard veteran Jim Murez, will be based in Eugene but with a five-member staff able to cover economic trends in the entire region, Parks said, adding that Seattle will not be neglected.

"Hasn't anybody ever heard of a telephone?" he joked.

The newsletter also will be available online.

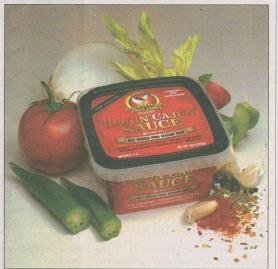
Parks bought the publication from founder Elliot Marple, who died in 2001. The newsletter has 1,100 loyal subscribers, Parks said, but in recent years he has struggled to juggle editing duties with a side business as a public speaker. Parks will stay full-time with Marple's through the end of the year, and serve as editor emeritus at least through 2010.

## What's sauce for the entrepreneur

Kevin Fortun hopes to do for sauces what his previous company, Fortun Foods, did for soups.

Fortun, who sold Fortun Foods' Stockpot soup operation in Redmond to Campbell Soup Co. in 1998, is about to roll out a line of refrigerated sauces to dress up home-cooked meals. The dozen sauces, which range from Marsala & Mushroom to Mulligatawny, will be sold through grocery stores and to restaurants and food service companies under the Fortun's Finishing Touch Sauces la-

The manufacturing operation will be based in Southern California with an administrative office in Kirkland, where Fortun supervises all seven companies he's launched since selling Stockpot.

Fortun's other business ventures include Hundred Acre Winery in Napa, Calif., Desert Sage restaurant in La Quinta, Calif., the Copper Ridge residential development in Ketchum, Idaho, and KGF Equestrian Center in Kirkland.
